Who can hunt?

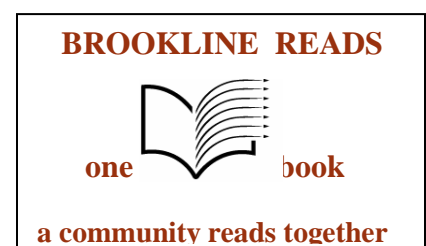
-Teens in grades 7-12. Make sure to register by April 11th.
